Running Order: Instinct, Novice, Open, Senior, Master

- Competitors do not earn qualifying scores towards any Barn Hunt Title when participating in a fun test .
- Competitors may enter any level they wish at a Fun Test, and may enter more than one level and or multiple times at the same level.
- A Barn Hunt Registration Number is NOT required for a dog to be entered in a Fun Test. However, participants must be familiar with BHA rules. Please visit www.barnhunt.com for the complete rulebook.
- Classes offered: Instinct (\$5/run) Novice, Open, Senior and Master (\$10/run each class).
- Open to ALL breeds/mixed breeds 6 months of age or older.
- Entry limit, 6 hours of judging.
- If Test is not full, Late entries and Day of Show entries will be accepted from (8:45 am to 9:45 am). Late and Day of show entry fees as follows: Instinct (\$7/run) Novice, Open, Senior and Master (\$12/run each class).
- Building opens at 8:30am. Check in 9:00am to 9:30am. 10 am first dog on the line.
- Trial will be held indoors in a heated building, on a concrete floor. Blind/staging area approx 15' x15' will be adjacent to the building under cover. Crating in vehicle/outside. Limited indoor crating available.
- Bitches in season may participate in panties.

Permission has been granted by the Barn Hunt Association, LLC to hold this Barn Hunt Fun Test under BHA rules and Regulations.

It is expressly understood that participants alone are responsible for the behavior of their dogs and/or children. General Information

It is the responsibility of each competitor to read and understand the current Barn Hunt Association, LLC Rules prior to participating in this event.

Possessing or training with personal tubes and /or live rats is not permitted on the event grounds at any time.

Events will be held indoors in a climate controlled facility. Dogs must be leashed or crated when not actively working. Please pick up after your dog and dispose of waste in appropriate containers. Multiple potty areas and fenced in areas are available.

Crating: Limited space available in climate controlled building.

Leashes and collars: Flexi-leads, Electronic Collars/Devices are NOT allowed on event grounds. Approved collars include: flat snap or buckle collars of solid construction and leather or nylon leads, limited slip martingale and single piece slip collars/leads, and harnesses. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced.

Dog aggression: Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the trial if justification is found by the judge and/or trial committee. Entry fees will not be refunded.

Bitches in season: Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class. They must wear pants at all times (including on course) while not being pottied. Entry fees for bitches that come into season will be refunded until the closing time if you wish to withdraw. The trial secretary must be notified prior to or upon arrival. Failure to do so will result in a disqualification and dismissal from the event.

Videotaping and photography: is allowed and encouraged!

Food services: There is a grocery store, several convenient stores and fast food restaurants within driving distance from the event location. There are also outdoor picnic tables.

Volunteers: Are appreciated and needed! See form at the end of the premium.

Spectators: Are valued and encouraged! Please be sure spectators have a basic understanding of the sport plus do's and don'ts.

Sportsmanship: All competitors/handlers and spectators are expected to follow the rules of the BHA, LLC and demonstrate good sportsmanship. Please do not discuss hide placement or any details of a dog's performance that may provide information or clues to other handlers or may be overheard. Please be cognizant of teams competing in the ring and avoid loud or disruptive distractions.

Payment and Entry Information:

Entries will be accepted as received. A BHA number is NOT required for the Fun Test.

Owners are responsible for entry errors.

Please write clearly and proof your entry. BHA, LLC will not make corrections once results are submitted.

Incomplete forms, nonpayment, and returned checks do not constitute a valid entry. Entries will not be considered valid without a signed Release Agreement Form. There is a \$25.00 fee for all returned checks.

Refunds are ONLY allowed if requested before the closing date 12/19/18.

No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, sick, excused, or barred from competition by action of the Event Committee.
